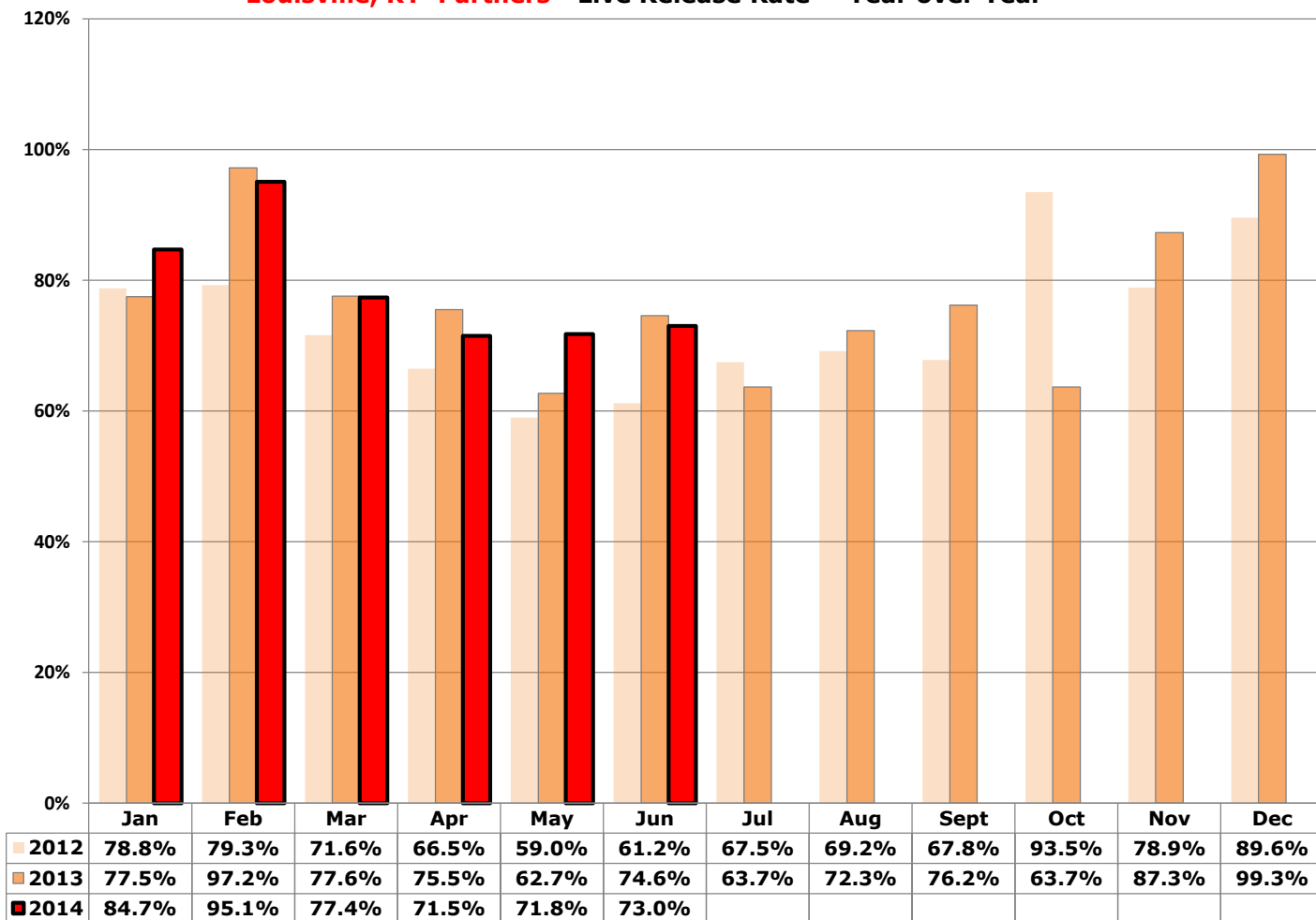

Partner agency total intake: sum of animals entering shelter from all sources (including intake/transfers from Community-reporting partners) minus # animals returned within 30 days of adoption. Total Intake does not include any animals dead on arrival at the shelter (DOA). NOTE: also does not include any animals returning to the shelter location from a foster home. These are location changes, not new intake.
Transfer from partner	Animals transferred in from a "Community-reporting" partner
Sub-categories (that must total 'Intake - Non-Partner sources' when summed)	
Owner Surrender	Animals relinquished by the owner for any reason (including Owner Requested Euthanasia). Animals returned more than 30 days after adoption are included here.

Outcome Terms

Total Live Release	Community/Partnership total live release: sum of (animals returned to owner, adopted (net of returns), Released to Field (felines), and transferred outside the partner organizations to agencies that guarantee adoption of the animals transferred to them) minus # animals returned within 30 days of adoption. Partner agency total live release: sum of (animals returned to owner, adopted, transferred to any agency that guarantees placement) minus # animals returned within 30 days of adoption.
Return to owner (RTO)	Animals included in shelter Intake count (current or prior reporting period) who are successfully reunited with their owners (i.e. reclaimed from shelter)
Adoption	Final adoptions only. Does not include animals placed in foster care, on overnight 'trial' stays, or on hold at shelter prior to completion of adoption agreement.
Return to Field	Stray felines included in shelter Intake (current or a prior month), altered (or verified as altered) and returned to their capture location as free-roaming felines
Other Live Release	Canines included in shelter intake (current or prior month) with live placements that do not fit into the other live outcome categories (e.g., law enforcement, assistance dogs, etc.).
Transfer Out to Partners	Animals transferred out to other agencies or organizations that are "Community-reporting" partners
Transfer Out to Non-Partners	Animals transferred to agencies that guarantee placement and are not "Community-reporting" partners
Euth – owner-request	Narrow category that should only include animals that were brought to the agency specifically for a low cost euthanasia option. Animals relinquished for adoption that are deemed "unadoptable" by the partner agency should not be included here.
Euth – all other [reasons]	Animals euthanized for all reasons EXCEPT Owner Requested Euthanasia
Died in care	Animals in the agency's care that die (cause is NOT euthanasia) during their stay (in shelter or foster)
Lost in Care	Animals lost while in agency's care (e.g., escape from foster home, stolen)
Targeted Spay/Neuter, TNR and RTF terms	
Targeted S/N [by animal type, other than TNR or RTF]	S/N conducted on owned animals. Does not include shelter animals (or from partner shelters, non-partner shelters, rescue groups, etc) altered before adoption, or felines altered through a TNR or RTF program.
TNR (Trap, Neuter, Return)	S/N conducted on feral and/or free-roaming felines returned to a colony post-surgery. Does not include owned animals or felines who are RTF.
RTF (Returned to Field)	S/N conducted on felines taken into the shelter, counted as intake and then returned to their capture location as free-roaming felines.

Capacity related terms

Number of permanent cages	This number only includes cages that are permanent (and functional) in the facility. Do not include cage banks that are wheeled out to handle overflow, pop up crates or condos that are set up throughout the facility.
Number of group housing units	Some facilities have designed colony housing for cats, or dog suites designed to house more than one animal at a time. List the number of these units available. Note: "T" or Guillotine style dog kennels ARE NOT group housing units and should be counted as one kennel run.
Dog shelter capacity (#)	The number of permanent cages (each counted as 1) + (the number of group housing units X the number of animals each is designed to hold).
Cat shelter capacity (#)	The number of permanent cages (each counted as 1) + (the number of group housing units X the number of animals each is designed to hold).
# of active foster homes	Number of foster homes with at least one animal in them on the last day of the month.
# of active satellite location kennels	Number of offsite/satellite adoption locations (e.g., PetSmart) with at least one animal in them on the last day of the month - each cage space counts as one location. Does not include animals brought to an satellite adoption location for the day then returned to the shelter if not adopted that same day.
End actual – in shelter	The number of animals by age group (e.g., dogs, puppies, neonate canines, cats, kittens, neonate felines) in shelter (excluding those animals in foster care) on the last day of the reporting month.
End actual – in foster	Number of animals in foster care/homes on the last day of the reporting month, by age group.
End Actual - in satellite locations	Number of animals in satellite locations on the last day of the reporting month, by age group.
End actual - total	Reported total end in care (at shelter + in foster + in satellite locations) on last day of reporting period, by age group.
Calculated end count	Calculated end in care number starting with last month's reported end in care number plus Intake, minus all outcomes (return to owner, adopted, returned to field, transferred, euthanized, died in care, lost in care)
Difference	The difference between the reported total end count and the calculated end count. Calculation: prior months' end count (as reported), plus current month intake, minus current month outcomes. Any "difference" number not equal to zero means there is an error in one or more of the intake/outcome numbers or an end count(s).
Shelter dogs as % capacity	The Total Canine adult equivalent in shelter divided by the dog shelter capacity #
Shelter cats as % capacity	The Total Feline adult equivalent in shelter divided by the feline shelter capacity #
Foster as % capacity	Total animals reported as "in foster" divided by # of active foster homes
Satellite locations as % capacity	Total animals reported as "in satellite locations" divided by # of active satellite location kennels
Dog adult equivalent in shelter	# dogs + (# puppies/2.5) For example: 2 dogs and 3 puppies would be equal to $2+(3/2.5) = 3.2$ dog adult equivalents.
Cat adult equivalent in shelter	# cats + (# kittens/2.5) For example: 2 cats and 3 kittens would be equal to $2+(3/2.5) = 3.2$ cat adult equivalents
Total adult equivalent in foster	2 dogs + 2 cats = 4 adults. 3 puppies + 3 kittens = 6 juveniles/2.5 = 2.4 adult equivalent. Total adult equivalent: $4 + 2.4 = 6.4$ adults equivalents in foster homes at month end.
Total adult equivalent in satellite locations	3 dogs + 2 cats = 4 adults. 3 puppies + 3 kittens = 6 juveniles/2.5 = 2.4 adult equivalent. Total adult equivalent: $4 + 2.4 = 6.4$ adults equivalents in satellite locations at month end.
