	If, during the 48-hour holding period for any dog or cat imported into the state for sale,		
	resale or adoption exhibits signs of infectious, contagious, parasitic or communicable		
	disease, including but not limited to coughing, sneezing, vomiting, diarrhea or bloody stool, such dog or cat is isolated and immediately examined by a veterinarian.
